CIRCULAR NO. 4 of 2004

DECENTRALISATION OF LEGAL AID AUTHORISATION

1. On the 13th of November 2001 Circular No. 3 of 2001 was issued.
2. The above Circular dealt with the Quality Control in respect of the issue of Legal Aid Instructions.
3. In terms of Circular 3 of 2001 certain Legal Aid officers were supervised by the National Office and were to obtain authorisation to issue Judicial instructions from the National office.
4. The Quality measures were introduced to eliminate among other things criticisms of the Auditor-General in regard to control over the issue of legal aid instructions.



5. Paragraph 10 of Circular No. 3 of 2001 provided that as more Justice Centres were established from time to time, legal aid officers then being supervised by the National Office of the Board would be allocated to such Justice Centres.
6. With effect from the 1st April 2004 no authorisation of legal aid instructions by the National Office in Braamfontein took place and all legal aid officers dealt with Justice Centres.
7. This Circular is issued to formally confirm the administrative arrangements that have been in place since 1st April 2004.
8. The result is that:
 - 8.1 A Justice Centre near the court responsible will in future authorise judicare instructions for that particular court.
 - 8.2 The National Office will cease issuing authorisation of judicare instructions.
 - 8.3 Judicare instructions will be issued by the Justice Centres in terms of the Legal Aid Board procedures and policies.
 - 8.4 All instruction forms relating to the authorisation of legal aid instructions by National Office shall be collected by the Justice Centre applicable for purposes of destruction as at 1st April 2004.
9. The exceptions to the above are:
 - 9.1 The National Office shall continue to be responsible for the engagement of Senior Counsel.
 - 9.2 The National Office shall continue to deal with appeals against refusal of legal aid.
 - 9.3 The National Office shall continue to deal with increased fees save as delegated to regional Operations Executive.
10. Nothing in this Circular changes the rules relating to the distribution of legal aid instruction firstly to legal practitioners at Justice Centres and thereafter to legal practitioners in private practice.
11. Legal aid officers who were supervised by National Office shall be supervised by Justice Centres. Such legal aid officers should communicate with the principal attorney (usually the Justice centre Executive) in the said Justice Centres to establish:

- 11.1 Whether the principal will visit the legal aid officer weekly to consider legal aid instructions awaiting approval; or
 - 11.2 Whether the legal aid officer should post the necessary documents to the Justice Centre for consideration by principal; and
 - 11.3 How the principal wishes the legal aid officer to deal with urgent matters.
12. The Supervisors of legal aid officers per Justice Centres are listed in Annexure "R" hereto.
 13. For the convenience of legal aid officers liaising with Justice Centres a list of Justice Centres and contact details is annexed hereto marked "B.1".
 14. Principals are hereby authorised to delegate their responsibilities but not their accountability for the matters dealt with in this Circular to professional assistants and/or advocates employed by the Board at the Justice Centre concerned, provided no delegation to any such professional assistant or advocate shall be effected unless the employee concerned has been in the service of the Board for at least one year. Any such delegation shall be in writing. Any delegation granted by any principal may be withdrawn by his/her or his/her successor in title. Any withdrawal of delegation shall also be in writing. Any supervisor's authority to authorise any legal aid instruction in terms of this Circular shall ipso facto terminate upon the termination of such supervisor's employment by the Board.
 15. Legal aid officers and legal practitioners are reminded that before a legal aid instruction can be issued to a legal practitioner, that legal practitioner has to be registered as an accredited practitioner with the Legal Aid Board. Supervisors will inter alia check that legal practitioners are accredited before authorising legal aid instructions. The accreditation database will in due course be made available on the Justice Centre IT network.
