SPECIFICATION FOR INSTALLATION OF BOOM GATE FINANCE

Legal Aid South Africa is an independent statutory body established by the Legal Aid Act, 1969 (Act 22 of 1969), replaced by the Legal Aid South Africa Act 39 of 2014. Its aim is to render legal aid to indigent persons as widely as possible within its financial means, including providing legal representation and advice at state expense as contemplated in the constitution. Legal Aid South Africa is a high-performance organization delivering its constitutional mandate to provide legal assistance to the poor.

The Legal Aid SA hereby invites suitably qualified and reputable service providers to submit proposals for installation of the boom gate.

1. REQUIRED SERVICES

1.1 Supply and install Rapid speed high-volume barrier automatic industrial vehicle traffic barrier/boom gate:

- * complete with 3m rectangular profile and LED lighting strip with red reflective stripes
- * The barrier/boom to be equipped with an electrical motor that lifts the boom arm on command of a remote actuator button
- * Boom Pole raise time 1.2 seconds including Batteries for backup function
- * Boom arm to be lockable in both up and down position
- * Including any miscellaneous/ancillary materials or equipment required to a complete full installation (contractor to confirm size at compulsory site briefing).

1.2 Supply and Installation of Wireless Gate Beam Infrared Sensor Set

1.3 Supply and install 51mm diameter x 355mm high powder-coated steel gooseneck (*for the installation of a 7-inch Hikvision Face Access Terminal- Which will be supplied by Legal Aid SA*)

1.4 Supply and installation of two-way intercom including cabling, push release button and all miscellaneous/ancillary materials required to complete full installation

1.5 Commissioning of the automatic boom gate systems and handover
